FINANCIAL POLICY AND PROCEDURES

RATES: The administration of Academy of Excellence publishes new rates on a Financial Information Sheet that is released in June for the following school year. Student accounts must be current before entering classes. All application enrollment fees are NON-REFUNDABLE!

SCHOLARSHIP VERIFICATION: Parents are required to complete scholarship payment verification via email or signing of check payment in a timely manner. Parents must complete verification within five business days. Late verification will incur a late fee of \$25.00 and will be added to the account balance. Initial:

CHARGES DUE TO WITHDRAWAL: SPECIAL NOTE: The admission fee is non-refundable. Early Withdrawal before end of school year fee of: \$500 which is not covered by scholarship (parents agree to be solely responsible for this fee) Initial:

WITHDRAWALS: If a student account is not up to date at the time of withdrawal or dismissal, all grades, records and transcripts will be held until any open invoice/balance is paid. No grades, records or transcripts will be released on the same day a student withdraws regardless of the account balance. Parents must have completed all withdrawal papers and paid all fees and tuition payments due in order for the school records to be sent to the receiving school. Withdrawals from school must be initiated and processed through the individual school offices. Withdrawal is not complete until the withdrawal form is turned in to the administration office and all open balances have been paid in full. An account left open will incur additional tuition fees & late fees until withdrawal papers are completed, returned and processed to the administration office. Initial:

LATE CHARGES: All payments for tuition, before and after school care, music lessons, or any other charges paid through the academy will be due by the billing date of each month. A late fee of \$25.00 will be added to any account with a balance due after the billing date. If, on the first day of a new month, the previous month's tuition is still outstanding, a letter will be mailed to the parent requesting payment in full by the 15th of the new month. If payment in full of the previous month's bill is not received by that time, the parents will be notified that they are subject to withdraw the students from school. Any student(s) withdrawn from Academy of Excellence must be re-registered and pay appropriate fees in order to return to classes.

CHECK FEES AND OTHER INFORMATION: A \$30.00 returned check fee will be charged for each time a check is returned by your bank. Checks returned for the first time will be re-deposited. After two (2) returned checks, cash, credit or debit card (online only), money order, or cashier's check must be used to make payments.

Report cards will not be released at the end of a grading period if the student's account (including tuition, lunch charges, payment for lost/misused books or damaged school property (chromebooks), outstanding fund-raising monies, etc.) is not paid up to date. The business office does not accept post-dated checks. All official academic records and transcripts will be held until any outstanding balance is satisfied. Initial:

DELINQUENT ACCOUNTS All payments for tuition, before and after school care, athletic fees or any other charges paid through the academy are due by the 5th of each month. Students with accounts more than 45 days past the due date will be subject to withdrawal from school. Families will be advised in writing of the necessary financial obligation in order to be readmitted. AOE reserves the right to impose any appropriate penalties in those situations where delinquent tuition or any other fees persist. These may include, but are not limited to, denial of re-enrollment, suspension of students, revocation of financial aid, restricting student participation in extracurricular activities, withholding of yearbooks, and withholding of transcripts and records. PLEDGE OF COOPERATION

Dear Academy of Excellence Parents/ Guardians,

As an essential part of the enrollment process, the pledge written below must be completed. It serves as a protective legal hedge for the benefit of our families and the school.

Conditions of Enrollment and Pledge of Cooperation:

- 1. I understand that it is a privilege, and not a right, for my child (ren) to attend Academy of Excellence ("AOE"). I further understand that all students are accepted on a probationary status. I further understand that the school reserves the right to dismiss any student who does not cooperate with any phase of the educational program and process, be it curricular or extracurricular, or whose attitudes and actions are not in harmony with the aims and ideals of AOE. I give AOE's administration full discretion in the discipline of my child, including the issuing of demerits, referrals, detention, suspension (in-school or out), and expulsion from the school for conduct deemed by AOE to be improper, regardless of where the incident(s) giving rise to such discipline occurs. Admission for one school year does not guarantee automatic admission for future school years.
- 2. I understand that AOE does not condone bullying of any kind. Aligning with our goals for a safe, nurturing atmosphere, through early intervention and prevention, AOE proactively addresses behavioral patterns and actions that evidence hateful disrespect toward any student. I understand that if an incident of bullying is reported and/or observed by faculty and/or administration, an investigation will be conducted to determine if the incident qualifies as bullying, as defined in the student handbook. I further understand that if I disagree with the conclusion of the investigation and/or the discipline imposed on my child, I am to request a conference with the principal and/or his or her designee(s).
- 3. I understand that AOE, in the interest of nurturing its school atmosphere and spiritual goals, has a "Zero Tolerance" policy regarding possession and /or use of illicit drugs on or off campus. If in the judgment of AOE's administration, it is determined my child(ren) should be drug tested, I agree to have my child(ren) tested, at my own expense, by an appropriate medical provider approved by AOE to conduct such a drug test. If I am unwilling to permit such a drug test, or to release the results of such test to AOE, I shall withdraw my child(ren) from AOE and thereby waive all rights to any recourse.
- 4. I understand and agree to the need for, not random, but reasonably determined investigations of student activities which may involve and include searching my child's or children's belongings (i.e., book or carrying bag, lunch box, purse, gym bag, etc.) and locker. In the case of secondary students, I also give permission for any motor vehicle in my student's possession to be

searched for stolen or other improper items. I ask that AOE's administration make a reasonable attempt to contact me prior to such a search in order to allow me to be present. If I am not

available by telephone after reasonable efforts to contact me have been made by AOE, I permit AOE's administration to search the vehicle.

- 5. I agree to cooperate fully with AOE's administration regarding all actions requested of me pertaining to my child's or children's enrollment at the school and in the enforcement of its rules and policies. I agree to cooperate with the policies and procedures of the school administration while also upholding the aims and ideals of the school and by encouraging my child(ren) to likewise abide by the aims and ideals of the school.
- 6. I understand that my child's or children's continued enrollment at AOE is conditioned upon my prompt and timely payment of all tuition and fees (including late fees). I further understand that in the event of withdrawal or expulsion of my child(ren) from AOE for any reason, I waive all rights to a refund of tuition and fees previously remitted and further understand that I shall remain obligated for any tuition and fees not yet having been paid. I have read and agree to abide by AOE's financial policies.
- 7. I acknowledge having access to and having read a copy of AOE's current handbook before execution of this application. I agree that my child's or children's enrollment at AOE is subject to all terms and conditions of the handbook which are fully incorporated herein by reference.

2023-2024 DRESS CODE GUIDE

The positive benefits of uniform dress standards include:

- encouraging a neat appearance
- facilitating school pride

Students in all grades may purchase uniforms from Custom Shirts and Uniforms or The Academy of Excellence.

All students must wear uniform-style clothing. When a student is out of dress code, we will try to resolve the situation with the clothing we have on hand, but, if it is not possible, we may have to call the parent/guardian to bring a change of clothes before the student returns to class and in some instances student(s) may be sent home. **Initial:**

Note: In all areas of dress and grooming, certain fads and styles may be deemed unacceptable by the administration at any time (such as piercings and tattoos).

GENERAL (FOR ALLSTUDENTS)

Our school uniforms consist of:

- 1. Collared polo shirts (burgundy or blue color) (Only acceptable logo is the AOE logo)
- 2. Skirts (khaki, plaid or navy)
- 3. Pants/Capris (khaki or navy) Shorts (khaki or navy)
- 4. Ties on chapel day listed in dress code pictures
- 5.. BackpacksClear or Mesh Material
- 6. Outerwear (worn in school) Sweaters, jackets must be All AOE branded apparel (NAVY or BURGUNDY). Articles of clothing worn outside the uniform must be true outerwear and not another shirt to change the appearance of the uniform. The best option to purchase approved outerwear is available through https://customshirtsanduniforms.com. *If a student is not wearing the proper outerwear as mentioned above, they will be asked to remove their outerwear (this includes jackets, sweaters, hoodies and pullovers).
- 6. NO Caps, hoods or bandanas permitted in the building.

- 8. Long sleeve shirts and girls' tights/leggings may be worn under uniforms and should be "one solid color."
- 8. Uniforms may have no rips, tears, frays, or faded color fabric.
- 9. Pants may not sag. NO jeans, joggers, cargo, carpenter, or corduroy pants allowed.
- 10.Students MUST wear SOLID black, solid white or black & white shoes appropriate for daily recess and PE. Sandals/shoes must have a back-strap and the heels should be no higher than 2". Shoes can NOT have any color, not even the lettering, design or logo. Please find below examples of appropriate shoe wear and unacceptable shoe wear:
